Public Comment: Maryanne Anderson asks what the village is doing to protect the village from battery

farms. Jerry Seymour explains they are waiting on the Town of Lenox to make the

Minutes: The board is presented with last meeting minutes. Dawn Collins makes a motion to

accept minutes with the date spelling correction. Marcia Rafte seconds the motion.

Record to Vote: All in favor - motion carried.

Clerk: Maddison Jaquin provides the Board with the bills and explains that she is having

difficulties getting this month's info into the new accounting system. She insists she is working with the software installers and Kathy from Canastota to get everything up

and running.

Fire Dept: Monte, the Fire Chief, told the Board the dust has been blown off the fire trucks as

there has been more fires in the past 2 months and there has been in 2 years. 1 In Wampsville, 2 in Canastota and 1 in Clockville. The fire department has a few

Monte discusses the accident and states the driving privileges have been suspended from the member who was driving during the accident.
